

# Privacy Policy

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

The types of personal information we collect and share depend on the product or service you have with us.

This information can include:

- Social Security number and income
- Account balances and payment history
- Credit history and credit scores

When you are no longer our customer, we continue to share your information as described in this notice. All financial companies need to share customers' personal information to run their everyday business. **What we do****How does Funding solution int Acceptance protect my personal information?**

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

**How does Funding solution int Acceptance collect my personal information?**

We collect your personal information, for example, when you

- Open an account or give us your income information.
- Apply for a loan or provide employment information.
- Give us your contact information.

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

**Why can't I limit all sharing?**

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliated to market to you

State laws and individual companies may give you additional rights to limit sharing.

## **Definitions**

### **Affiliates**

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- Funding solution int Acceptance Corporation does share information about your credit worthiness with our affiliates.

### **Nonaffiliated**

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- Funding solution int Acceptance Corporation does not share with nonaffiliated so they can market to you.

### **Joint marketing**

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- Funding solution int Acceptance Corporation does not jointly market.
